## Second Equal Access Buy-Back Offer Closed – Update Your Bank Account Details with Automatic share registry

Amani Gold Limited (ACN 113 517 203) (**Amani** or the **Company**) advises that it has closed the Second Equal Access Buy-Back announced on 30 August 2024 (**Second Equal Access Buy-Back**).

A total of 1,779,509,888 shares will be bought back at \$0.00035 each and cancelled under the Second Equal Access Buy-Back. The shares bought back under the Second Equal Access Buy-Back will cost Amani approximately A\$622,828.

Following the cancellation of the 1,779,509,888 shares bought back under the Second Equal Access Buy-Back, the Company's total number of shares on issue will be reduced to 21,449,587,124. This reduction will decrease the number of shareholders to approximately 848 and thereby lowering administration costs associated with maintaining the share register.

Payment of the proceeds will be made to the participating shareholders on 19 December 2024 and prior to the Delisting date of 20 December 2024, to the bank account registered with the share registry.

### Future Disclosure Obligations after Delisting

Amani formally applied to be removed from the official list of ASX (**Official List**) (**Delisting**) under ASX Listing Rule 17.11 and received shareholder approval for the Delisting at its Annual General Meeting on 8 November 2024. Subsequently, the Company will delist from the ASX on 20 December 2024 (refer to Company announcement on 2 October 2024 for further details).

For so long as Amani continues to have more than 100 shareholders post-Delisting, the Company will be an "unlisted disclosing entity". As such, the Company will continue to be subject to continuous disclosure obligations under the Corporations Act 2001 (Cth) (**Corporations Act**). The Company will still provide disclosure to shareholders of material matters in accordance with the Corporations Act on the Company's website and via email to those shareholders who have registered their email with the Share Registry.

The Company will also continue to lodge annual and interim financial statements (audited or auditor-reviewed, respectively) in accordance with the Corporations Act and invite shareholders once a year to an Annual General Meeting.

Shareholders have also approved a 1-for-1000 share consolidation effective on 29 January 2025.
